CONSENSUAL SECURITY INTEREST

You grant us a security interest in all individual and joint share and/or deposit accounts you have with us now and in the future to secure your credit card account. Certificate Secured - The Annual Percentage Rate (APR) will be the dividend rate associated rate being paid on the Certificate offered as security plus Three (3) percent. The Certificate must be renewed until the advance is completely paid. Failure to renew will result in default under the Plan. When the Certificate is renewed, the APR will change to reflect the new dividend rate. Any increase in the APR will result in more payments of the same amount until what you owe has been repaid. The present annual percentage rate will be disclosed on the voucher at the time of the advance.

Pricing Policy – The loan pricing policy is based on the inherent risk associated with individual borrowers, loan types and loan term.

Late Payment Fee – Loans 15 days past due, will be assessed a \$35.00 late payment fee.

Over Credit Limit Fee – You will be charged a fee of \$35.00 per month if you are 10% over your credit limit on your Visa Credit Card.

Filing Fee – You will be charged a lien filing fee at the time of an advance if the credit union takes a security interest in your collateral. The amount of the filing fee will be based upon the amount of the fee required by state law for the credit union to obtain a lien on your property. The amount of the filing fee will be disclosed on the voucher.

Collection Costs – You agree to pay all costs of collecting the amount you owe under this agreement to the extent permitted by state law.
